

#Radiance21 Scholarship Agreement

This scholarship Agreement (“Agreement”) is made effective the date last signed below by and between Syaza Nazura binti Noor Azmi & #Radiance21 team (“Radiance21”), and the Recipient whose name is signed below.

The Parties Agree As Follows:

1) Scholarship amount.

- a) Radiance21 will allocate a total of MYR _____ that will be solely used to cover tuition fees and any other academic-related fees.
- b) The tuition payments will be made directly to the institution by Radiance21. In the event that this is not possible, Radiance21 will transfer the amount listed on the invoice to the Recipient, who will then pay the tuition fees on their own, and provide Radiance21 with a copy of the tuition payment receipt as proof.
- c) The scholarship duration will be until the Recipient has finished their course of studies at their current institution, or until the total scholarship allocation listed above is used up, whichever comes first.

2) Enrollment

- a) Recipient must be enrolled as a full-time student in the _____ program at their institution, _____.
- b) Recipient is not allowed to change their program or institution without informing Radiance21 beforehand.

3) Satisfactory academic progress

- a) Recipient is expected to maintain satisfactory academic progress throughout the course of their studies.
- b) Recipient should maintain a minimum grade point average (GPA) of 2.5 every semester. Failure to do so may cause the scholarship to be put on hold until the Recipient is able to achieve the minimum GPA for the upcoming semesters.
- c) Recipient must notify Radiance21 of the results for every semester via email at the end of every semester. They may do so by attaching an unofficial transcript or a screenshot of their results and sending it to Radiance21. Failure to do so may cause the tuition fees for the next semester to be put on hold.
- d) Recipient must not make any changes or alterations to the results. Should there be any alterations made to the results given to Radiance21, the scholarship may be revoked.

4) Community service project

- a) Recipient is expected to participate in a minimum of one community service project for each year that they are sponsored by Radiance21.
- b) The community service projects can either be an individual project by the Recipient, a group initiative, or an institution-directed project,
- c) Some of the community service projects that the Recipient can participate in are, but not limited to, as follows:
 - i) A visit to an orphanage/elderly home
 - ii) A motivational talk at a school/college
 - iii) Participating in a soup kitchen initiative

- iv) Participating in Projek Kalsom/other motivational camps
- v) Volunteering at a non-profit organisation
- d) Participation in Projek Inspirasi does not fall under this category as it is a requirement for all Recipients.
- e) Recipient will need to share a short reflection on their involvement in the community service project, and this will be shared with the public on the #Radiance21 website, <http://radiance21.avh.me> .

5) Participation in future Projek Inspirasi

- a) Projek Inspirasi can either refer to:
 - i) The online Google Hangouts on Air session, or
 - ii) The physical Projek Inspirasi at a high school
- b) More information regarding Projek Inspirasi will be given out as the time comes, but the Recipient is expected to participate in at least one future Projek Inspirasi event, either as a facilitator or providing support in organising the event.
